

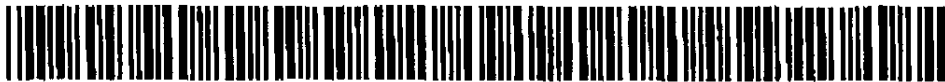

**ARTICLE I
NAME**

The name of this Limited Liability Company is 125 NDS, LLC.


**ARTICLE VII




