ARTICLES OF ORGANIZATION FOR CE & MB REAL ESTATE HOLDINGS, LLC

### **ARTICLE I - NAME**

The name of the Limited Liability Company is CE & MB REAL ESTATE

### **ARTICLE II - ADDRESS**

### **ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS**

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning at least ninety (90%) percent of the outstanding Member Units of the Limited Liability Company.
