ARTICLE V. REGISTERED AGENT

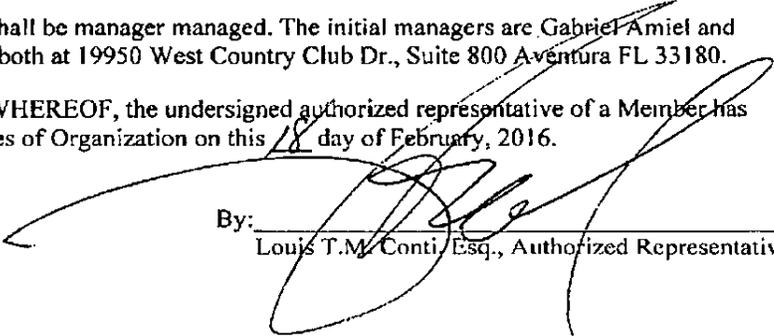
