**ARTICLES OF ORGANIZATION
OF
NWC HOLDINGS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be NWC Holdings, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address of the initial principal office of the Company shall be PO Box 112727 Naples, Florida 34108. The street address of the initial principal office of the Company shall be 2367 Vanderbilt Beach Rd. #810, Naples, Florida 34109.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company shall be managed by one or more Managers in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.


