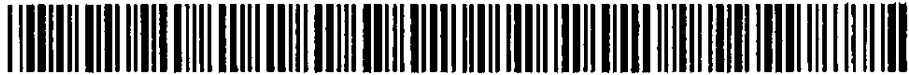


**ARTICLE IX - Powers**

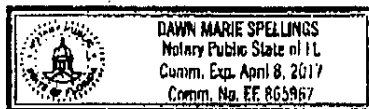
