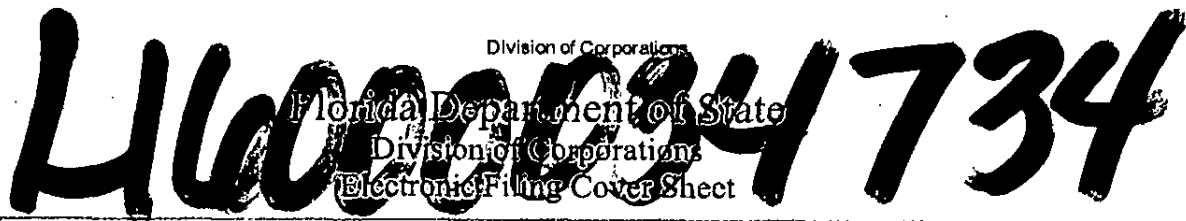

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned persons hereby amend and restate the Electronic Articles of Organization for Limited Liability Company for Neurocognitive Football Lawyers, LLC (the "Company"), which were filed on February 18, 2016 and which were assigned Document No. L16000034734. The purpose of these Amended and Restated Articles of Organization is to cause the Company to be formed under, and to be governed by, the Professional Service Corporation and Limited Liability Company Act.

ARTICLE I - Name

The Company shall be a professional limited liability company, and the name of the Company shall be:

The Company shall be perpetual, except as otherwise provided in the operating agreement, or the governing documents, pertaining to the Company, and except as otherwise provided by law.

ARTICLE IV - Nature of Business

The general nature of business to be transacted by the Company, or the objects or purposes of the Company, shall be as follows:

- (a) To engage solely and specifically in the practice of law and in the business of providing legal services.

- (d) In general, to have and exercise all powers conferred by the laws of the State of Florida upon professional limited liability companies and professional service corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE V - Management

The Company shall be a member-managed professional limited liability company.

ARTICLE VI - Members

The names, addresses, and percentage interests of the members of the Company are as follows: Gibbs & Parnell, P.A., 722 E. Fletcher Ave., Tampa, FL 33612, 30%; Jeffrey D. Murphy, P.A., 800 W. Kennedy Blvd., Suite 3910, Tampa, FL 33602, 30%; and Holliday Karatinos Law Firm, PLLC, 18920 North Dale Mabry Highway, Suite 101, Lutz, FL 33548, 30%. No member of the Company shall enter into any type of agreement vesting another individual or entity with the authority to exercise any of that member's voting rights or powers in the Company.

ARTICLE VII - Admission of Additional Members

The members may admit additional members of the Company. However, no individual may be admitted as a member of the Company unless such individual is duly licensed and otherwise legally authorized to render legal services as an attorney at law, and no entity may be admitted as a member of the Company unless such entity is a professional service corporation or a professional limited liability company that is duly licensed or otherwise legally authorized to render legal services through one or more duly licensed attorneys at law.

ARTICLE VIII - Right of Members to Continue Business

The remaining member or members of the Company, if any, shall be entitled to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.
