ARTICLES OF ORGANIZATION OF BRW VISTAWILLA, LLC

The undersigned hereby organizes a limited liability company under the provisions of the Florida Revised Limited Liability Company Act (the "Act"), and pursuant to the following Articles of Organization:

- (i) pay pensions and establish pension plans, pension trust, profit-sharing plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members officers, agents, and employees;
- be a promoter, incorporator, shareholder, partner, member, associate, or manager (k) of any corporation, partnership, joint venture, trust, or other entity; and
- make payments or donations or do any other act not inconsistent with law that (l) furthers the business of the Company.

This Company shall have perpetual existence, commencing on the date that the Articles of Organization are filed with the Florida Department of State.
