The undersigned as authorized representative on behalf of sole member identified in Article IV, for the purpose of becoming a limited liability company under the laws of the State of Florida, provides for the formation, rights, privileges, and immunities of limited liability companies for profit and further declares that the following Articles shall serve as the charter and authority for the conduct of business of the limited liability company.

# **ARTICLE I**

### NAME AND PRINCIPAL PLACE OF BUSINESS
