ARTICLES OF ORGANIZATION

OF

STAR VENTURE, LLC

The undersigned Manager(s), for forming a Florida Limited Liability Company pursuant to Chapter 605 of the Florida Statutes, hereby adopts the Following Articles of Organization.

ARTICLE I: NAME

The name of the LLC shall be:

STAR VENTURE, LLC

ARTICLE II: PRINCIPAL OFFICE

The principal place of business of this LLC shall be:

ARTICLE III: REGISTERED AGENT

ARTICLE IV: MANAGER

The names and street addresses of the initial Manager, who shall hold office the first year of the LLC's existence or until her successors are elected, is:

ARTICLE V: TERM OF EXISTENCE

This LLC is to exist perpetually, commencing upon filing and acknowledgment hereof as provided by Florida State Statutes Chapter 605.

ARTICLE VI: NO ADDITIONAL MEMBERS

The operating agreement shall list the initial member of the LLC and no additional members may be admitted to the LLC.

ARTICLE VII: VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of managers, and for all other purposes, shall be vested exclusively in the member.

ARTICLE VIII: NATURE OF BUSINESS

This LLC may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation. The LLC will not engage in any transaction prohibited under Internal Revenue Code Sections 4975 or 408.

ARTICLE IX: MANAGER-MANAGED

The LLC shall be a manager-managed company, and the member shall not take part in the operation of the company's affairs.


ARTICLE X: INDEMNIFICATION

The LLC shall, to the fullest extent permitted by Florida Statutes Chapter 605, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said section from and against any and all of the expenses, liabilities or other matters referred to in or covered by said section, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Operating Agreement, other agreement, vote of the member or disinterested managers or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a manager, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person.

ARTICLE XI: AMENDMENT

This LLC reserves the right to amend or repeal any provisions contained in these Articles of Organization or any amendment hereto, and any right conferred upon the members is subject to this reservation.

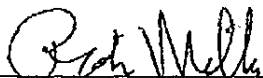
