**ARTICLES OF ORGANIZATION  
OF  
COVENANT HOME HEALTH HOLDING, LLC,  
(A Florida Limited Liability Company)**

**ARTICLE I  
NAME**

The name of the Limited Liability Company is Covenant Home Health Holding, LLC, (the "Company").

**ARTICLE II  
ADDRESS**

The mailing address and street address of the principal office of the Company is:

**ARTICLE III  
DURATION**

The period of duration for the Company shall begin on the date of filing these Articles of Organization with the Florida Secretary of State and shall have a perpetual existence and duration, until terminated in accordance with applicable law.

**ARTICLE IV  
MANAGEMENT**

The Company is a manager-managed limited liability company. The sole manager of the Company is Covenant Health and Community Services, Inc., a Florida not-for-profit corporation.

**ARTICLE V  
PURPOSE**

The Company is a wholly-owned subsidiary of Covenant Health and Community Services, Inc., a Florida not-for-profit corporation, and is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") or the corresponding provision of any future federal tax code.

**ARTICLE VI  
NO PRIVATE INUREMENT**

No part of the net earnings of the Company shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. The net earnings of the Company shall inure solely to the benefit of the Company's sole member, Covenant Health and Community Services,

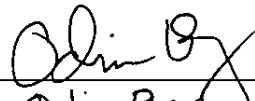
