ARTICLE I <u>NAME</u>

The name of the Limited Liability Company is Covenant Home Health Holding, LLC, (the "Company").

ARTICLE IV MANAGEMENT

ARTICLE VI <u>NO PRIVATE INUREMENT</u>

No part of the net earnings of the Company shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. The net earnings of the Company shall inure solely to the benefit of the Company's sole member, Covenant Health and Community Services, Inc., a Florida not-for-profit corporation, and a tax-exempt corporation under Section 501(c)(3) of the Code.

ARTICLE VII DISSOLUTION

Upon the dissolution or winding up of the Company, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Company, shall be distributed to its sole member, Covenant Health and Community Services, Inc., a Florida not-for-profit corporation.
