#### **ARTICLE V MANAGEMENT**

The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

#### **ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the Company's initial registered office in Florida is **12218 Creek Edge Dr. Riverview, FL 33589**, and the name of its initial registered agent is **Aaron Spuler**. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 605.0113, Florida Statutes.

#### **ARTICLE VIII ACKNOWLEDGMENT**




