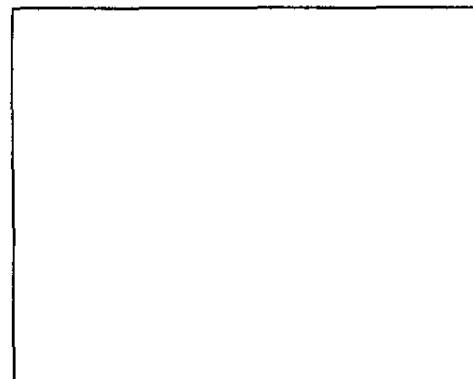

ARTICLE I
NAME


