

ARTICLES OF ORGANIZATION OF BISCAYNE ATLANTIC RIVERCHASE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Biscayne Atlantic Riverchase, LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 200 S. Park Road, Suite 301, Hollywood, Florida 33021.

The Company shall be managed in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company.
