**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is MARISOL, LLC (the "Company").
