**DURATION**

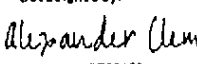
The Company's existence commenced effective as of March 3, 2016 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

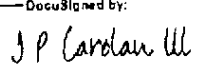
