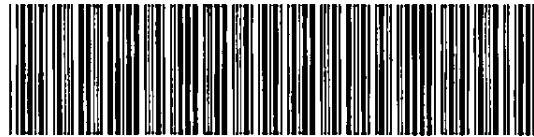

The Articles for **BALTON INVESTMENTS, LLC** were filed on March 2, 2016 and were assigned document number L16000043871.




Joseph Balzano, the disassociating member and resigning manager, has given written notice of the disassociation/resignation to the Company in writing.


