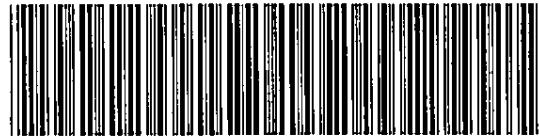

Pursuant to the applicable provisions of Sections 605.0202 of the Florida Statutes, the undersigned Florida Limited Liability Company, **Tree Frog Tree Company LLC** (hereinafter the "Company"), desiring to amend and restate its Articles of Organization, hereby certifies:

FIRST: The Company's Articles of Organization were filed with the Secretary of State of Florida on March 4, 2016, Document Number L16000045927.

SECOND: These Amended and Restated Articles of Organization supersede the original Articles of Organization and all amendments to them. These Amended and Restated Articles of Organization were adopted and approved by all of the Members and Managers of the Company. 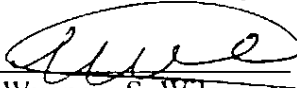

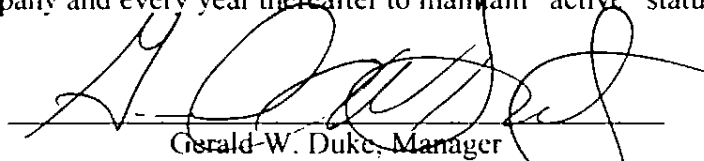

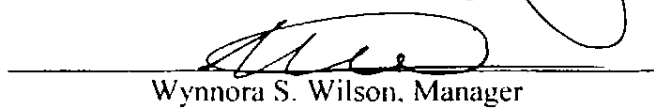
