

### ARTICLES OF ORGANIZATION

The undersigned subscribes to these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act.

## **ARTICLE I**

The name of this limited liability company shall be Sweet Queens, LLC

## ARTICLE II

The purpose for which this limited liability company has been organized is:

- To own, hold, sell, internet sell, rent, lease, mortgage, prepare, cook, install, service, assign, transfer, operate, produce, copyright, publish, manufacture, market, promote or otherwise deal with certain actions involving edible desserts, other foods fit for human consumption, and equipment used to manage restaurants located in various counties in the state of Florida and other areas.
