The undersigned authorized representative, desiring to form a limited liability company under the Florida Revised Limited Liability Company Act, hereby states the following:

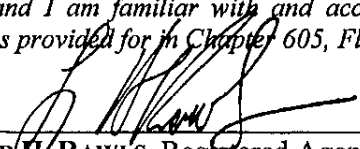

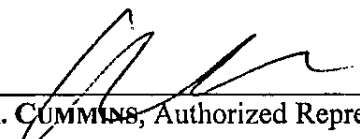
