### ARTICLES OF ORGANIZATION

# MONK'S INTELLECTUAL PROPERTY SERVICES, LLC

#### a Florida Limited Liability Company

FIRST: The name of the Limited Liability Company shall be MONK'S INTELLECTUAL PROPERTY SERVICES, L.L.C. (hereinafter referred to as the "Company").

<u>SECOND</u>: The mailing address and street address of the principal office of the Limited Liability Company is 1605 Main Street, Suite 1001, Sarasota, Florida 34236.

THIRD: The duration of the Company's existence shall be perpetual.

<u>FOURTH</u>: The purposes for which the Company is organized are any and all lawful purposes for which a Limited Liability Company may be organized pursuant to the laws of the State of Florida and the United States.

FIFTH: The Company shall be managed by its Manager(s). Initially, there shall be THREE (3) Managers whose name and addresses are JOSEPH F. <u>SIXTH</u>: Company shall be initially authorized and empowered to issue one class of Membership Unit.

<u>SEVENTH</u>: By majority vote of authorized and outstanding Membership Units, the Members may agree to admit additional Members to join the Company and establish the terms of their contributions to join.

<u>EIGHTH</u>: In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members may continue the business thereof.

NINTH: Whenever a Member or his legal representative requests a step-up election under Section 754 of the Internal Revenue Code as the same may be amended from time to time, such election shall be made as all Members of the Limited Liability Company, upon subscription for units therein, hereby irrevocably consent to such election when requested by any other Member.
