ARTICLES OF ORGANIZATION  
FOR

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of SPRING VALLEY PACKING, LLC ("Company"), under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I  
NAME

The name of the limited liability company is SPRING VALLEY PACKING, LLC.

ARTICLE II  
PURPOSE AND POWERS

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 605, Fla. Stat., as the same may be amended from time to time.

The Company shall admit new members as provided in the Operating Agreement of the Company.


**ARTICLE VII**


