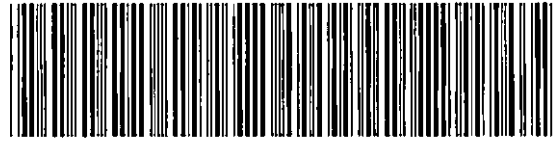

ASSIGNMENT OF INTEREST IN FLORIDA LIMITED LIABILITY COMPANY




