ARTICLES OF ORGANIZATION OF GMC PINEBROOK, LLC

The undersigned organizer hereby adopts the following Articles of Organization under the Revised Florida Limited Liability Company Act.

ARTICLE I - NAME

ARTICLE IV - MANAGEMENT
