ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of the Members, desiring to form a limited liability company under and pursuant to the Revised Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is MTC Longview LLC (the "Company").

ARTICLE II. ADDRESS

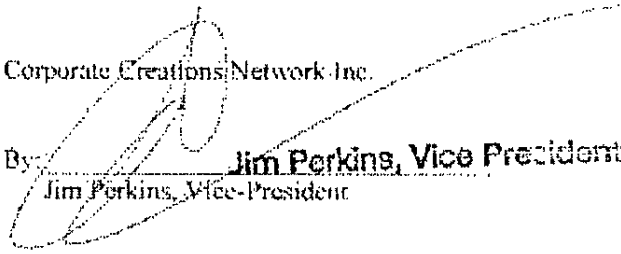
