ARTICLES OF ORGANIZATION  
OF  
M6 FARMS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Chapter 605 of the Florida Statutes), hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I  
NAME

The name of this limited liability company is **M6 Farms, LLC** (the "Company").

ARTICLE II  
ADDRESS

The Company's mailing address shall initially be **9435 Pinetree Dr., Lake Wales, FL 33898**, and the street address of the Company's principal office shall initially be the same.

ARTICLE III  
DURATION

The Company's existence shall be perpetual, beginning on **February 22, 2016**, unless the Company is earlier dissolved as provided in these articles of organization, the Company's operating agreement, or by applicable law.

ARTICLE IV  
PURPOSES AND POWERS

This Company is organized for the purpose of transacting any and all lawful business for which limited liability companies may be formed under the Florida Revised Limited Liability Company Act. The Company shall have all the rights, privileges, and powers now or hereafter available to limited liability companies under the laws of the State of Florida.

Except as authorized by a manager, no member is an agent of the Company or has the authority to make any contracts, enter into any transactions, or make any commitments on behalf of the Company.

Any provision of the operating agreement adopted by the members may be repealed or altered and new provisions may be adopted by the members, in accordance with the operating agreement or the Florida Revised Limited Liability Company Act, or any successor thereto.

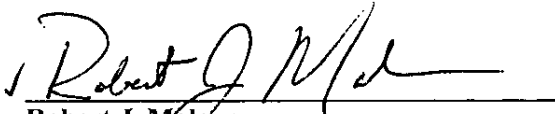
#### **ARTICLE VIII AMENDMENT OF ARTICLES**
