### FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came before the Court on the Report of Magistrate Robin E. Lanigan. On December 28, 2016, the Magistrate held an evidentiary hearing on the Petition for Dissolution of Marriage with Property and Dependent or Minor Child(ren) in this case; made proposed findings and recommended entry of a judgment similar to this one. The Court accepts the Magistrate's report and proposed findings and will enter the judgment below. The Court, based upon the Magistrate's Report, finds:

- Α. The Court has jurisdiction of the parties to and the subject matter of this action.
- At least one of the parties has been a resident of the State of Florida for more B. than six (6) months immediately before the filing of the Petition for Dissolution of Marriage.
- C. This action was properly referred to the General Magistrate pursuant to Rule 12.490 Florida Family Law Rules of Procedure and current administrative orders of Court. Neither party has filed an objection to the referral to General Magistrate, such that each party is deemed to have actually or constructively consented to the referral. Accordingly, the General Magistrate has jurisdiction over the parties to and subject matter of this cause of action.
- D. The parties were married on January 27, 2008, and ceased living together October 2008. The Respondent has been removed from the United States,

their name alone and shall indemnify and hold harmless the other from said debt.

- 3. PARENTING PLAN. The Parenting Plan should be incorporated into a final judgment, a copy of which is attached to the Final Judgment as "Exhibit A" and incorporated herein by reference. The parties shall comply with the terms of the Parenting Plan and the terms contained therein shall be enforceable by the Court.
- 4 CHILD SUPPORT. The Respondent shall file a financial affidavit forthwith.

  A subsequent hearing shall be conducted to determine guideline child support including any retroactive support.
- RESTORATION OF NAME. The Petitioner's name shall be restored to her maiden name, to-wit: KATHRYN LYNN SING.
- 6. **RESERVATION OF JURISDICTION.** With the exception of Paragraph 1 herein above, this Court retains jurisdiction to enforce, amend or modify the provisions contained herein.
