A) ARTICLE V. PURPOSE AND POWERS

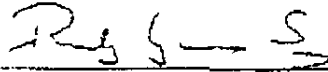

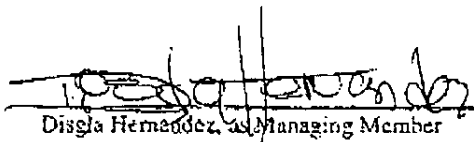
B) ARTICLE VI. CAPITAL CONTRIBUTIONS
