**ARTICLES OF ORGANIZATION
OF
JAE MIAMI DADE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company is JAE MIAMI DADE, LLC (the "Company").

ARTICLE II – ADDRESS

The principal street and mailing address of the Company shall be: 6401 Congress Avenue, Suite 100, Boca Raton, Florida 33487.

ARTICLE III – PURPOSE

The Company is formed for any purpose or purposes for which a limited liability company may be formed pursuant to the Act.

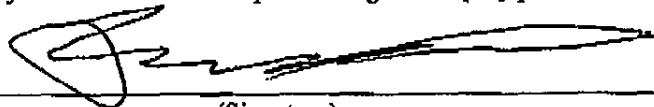

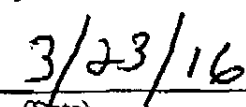
