

ARTICLE VIII



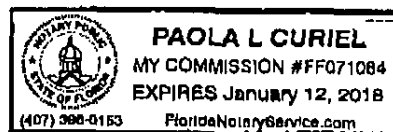
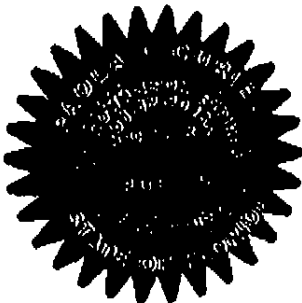
