**ARTICLES OF ORGANIZATION
OF

The undersigned WILLIS J. MULLET, organizer on behalf of the sole member of Current Warehouse, LLC, hereby presents these Articles of Organization as the Articles of Organization of Current Warehouse, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Current Warehouse, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
