



The undersigned, pursuant to the provisions of Chapter 605, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **MJI BEACHES, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on March 25, 2016, and assigned document number L16000058860.
