ARTICLES OF ORGANIZATION OF WS HOLDING OF ST. PETE. LLC

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name 1

The name of this limited liability company (the "Company") shall be WS Holding of St. Pete, LLC.

ARTICLE II

Principal Office and Mailing Address
