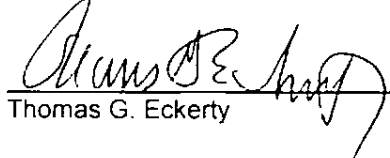
**ARTICLES OF DISSOLUTION

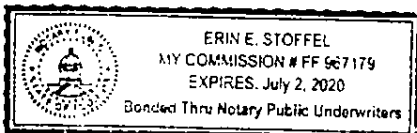

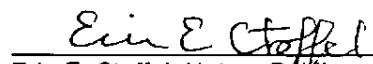
