**ARTICLE V - Operating Agreement**

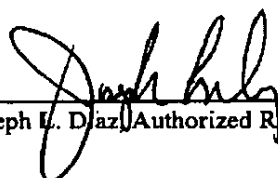

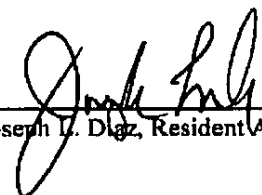
