AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF PET PARADISE-LAS COLINAS RE, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Pet Paradise-Las Colinas RE, LLC, originally filed on March 30, 2016, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME
