**ARTICLES OF ORGANIZATION
OF
SJR CAPITAL I, LLC**

The undersigned, Farrar J. Barker, a natural person competent to contract and an authorized representative of SJR Capital I, LLC, hereby presents these Articles of Organization as the Articles of Organization of SJR Capital I, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is SJR Capital I, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the Company's initial principal office is 438 Captain Circle, Destin, Florida 32541. The Company's initial mailing address is P.O. Box 5407, Destin, Florida 32540.

ARTICLE III - PURPOSE AND POWERS


ARTICLE VI - MANAGEMENT


