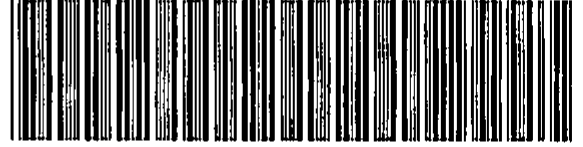



### AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned member, desiring to amend and restate the articles of organization of the limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Amendment and Restatement:

1. The name of the limited liability company is **EDU FIRST LLC** (the "**Company**").

The purpose for which the Company is formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


#### **ARTICLE VII. ADDITIONAL MEMBERS**
