ARTICLES OF ORGANIZATION OF
AGV VERSAILLES I HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I
NAME

The name of the limited liability company shall be AGV VERSAILLES I HOLDINGS, LLC (the "Company").

ARTICLE II
MAILING ADDRESS

The mailing address for the Company shall be 13061 SW 80 Street, Miami, FL 33183.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Company is 13061 SW 80 Street, Miami, FL 33183 and the name of the company's initial Registered Agent for service of process in the State of Florida, at that address is Ary Velasco.

ARTICLE IV
PURPOSES AND POWERS

The term and duration of the Company shall be perpetual, unless terminated in accordance with the Operating Agreement of the Company or otherwise terminated in accordance with law.

**ARTICLE VI
STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company shall be located at 13061 SW 80 Street, Miami, FL 33183, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

**ARTICLE VII
MEMBERSHIP RESTRICTIONS**

Additional Members may be admitted to the Company only upon the unanimous consent of all existing Members of the Company. Contributions required of new Members shall be determined as of their time of admission to the Company in accordance with the Operating Agreement of the Company. A Member's interest in the Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company, and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.

**ARTICLE VIII
MANAGEMENT**

All Company powers shall be exercised by or under the authority of, and the business and affairs of this Company shall be managed by one or more Managers. Accordingly, the Company is a Manager-managed limited liability company. The name of the initial Manager is Ary Velasco and his mailing address is 13061 SW 80 Street, Miami, FL 33183.


