**ARTICLES OF ORGANIZATION
OF
CUTANEA, LLC**

The undersigned, David C. Adams, a natural person competent to contract and the sole member of Cutanea, LLC, files these Articles of Organization of Cutanea, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Cutanea, LLC, which is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company is 2427 Rocky Shores Drive, Niceville, FL 32578. The Company's principal office may hereafter be at such other place or places as its member or members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE VI - MANAGEMENT




