**ARTICLES OF ORGANIZATION
OF

The undersigned, Thomas Andrew Marks and Kristen P. Marks, husband and wife, as tenants by the entirety, who are natural persons competent to contract and the members of KNOT AT WORK INVESTMENTS, LLC, file these Articles of Organization of KNOT AT WORK INVESTMENTS, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is KNOT AT WORK INVESTMENTS, LLC, which is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
