

1. **Name.** The name of the limited liability company is **THE NEW CHAPTER BEGINS, LLC**
2. **Purpose.** The purpose of this limited liability company is for real estate acquisition, management and development and any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the registered office of the limited liability company is as follows:  




