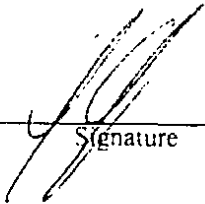

**WRITTEN CONSENT OF MANAGERS AND MEMBER
TO DISSOLVE VENTURES TWO LLC**

The Managers and Member hereby take the following actions by unanimous written consent to dissolve VENTURES TWO LLC, a Florida limited liability company (the "LLC"):
