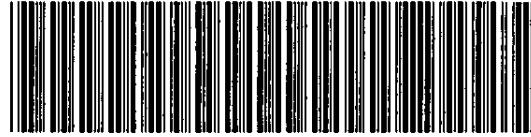



**ARTICLES OF ORGANIZATION
OF
ENGLISH AUTOMOTIVE SPECIALIST, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 605).

1. Name. The name of this limited liability company is English Automotive Specialist, LLC ("Company").
2. Duration. The Company shall exist from the date of filing these Articles with the Department of State and shall have a perpetual duration until the occurrence of any of the events specified in Florida Statutes Section 605.0701, unless continued by the unanimous consent of all of the remaining members or until terminated by the terms of any Operating Agreement between the members.
3. Mailing Address. The Company's mailing address is: 428 McDaniel Street, Tallahassee, Florida 32303.
4. Additional Members. Additional members to the Company may be admitted, but only if the members agree to the admission of the additional members and to the terms of admission all in accordance with the terms of the Operating Agreement.
5. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, withdraws, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall continue.
6. Management of the Company. The management of the limited liability company is reserved to one or more managers, as described in the Operating Agreement. John K. Jackson shall be the initial manager.
7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
8. Date of Existence of the Company. The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.
9. Registered Agent and Office. The name of the initial registered agent of the Company is: Christiana T. Moore, 428 McDaniel Street, Tallahassee, Florida 323031.


