



**ARTICLES OF ORGANIZATION
OF
MD PA-N JERSEY, LLC**

1. Name. The name of this limited liability company is **MD PA-N JERSEY, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
2. Duration. The Company's existence shall be effective as of April 5, 2016 and shall thereafter be perpetual.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Principal Office. The mailing and street address of the Company's principal office is 3717 W. North B Street, Tampa, Florida 33609.
5. Registered Agent and Office. The name of the initial registered agent of the Company is F & L Corp. The street address of the initial registered agent of the Company is One Independent Drive, Suite 1300, Jacksonville, Florida 32202.
6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company shall be Metro Diner Management, LLC, a Florida limited liability company.
7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
