

ARTICLE VIII



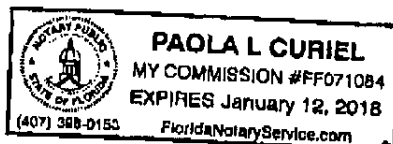
