MANAGEMENT**

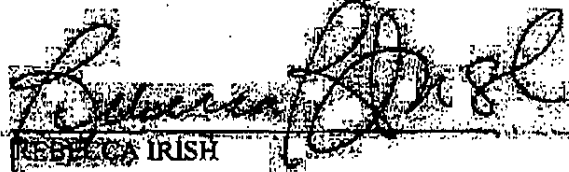
