ARTICLES OF ORGANIZATION
for
PRIMEAU & COTTONE, PLLC
a Florida Professional Limited Liability Company

The undersigned, in forming a Florida Professional Limited Liability Company ("Company") under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Organization for such Company.

ARTICLE I - NAME

The name of the Company is Primeau & Cottone, PLLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 110 SE 6th Street, Suite 1749, Fort Lauderdale, Florida 33301.

ARTICLE III - PURPOSE

The Company is organized for the purpose of engaging in the business of rendering professional legal services in the State of Florida by and through the Company's members, officers, employees and agents, as those terms are used in Section 621.06 (or successor legislation), Florida Statutes, who are duly licensed or otherwise legally authorized to practice law in the State of Florida, and transacting any and all other lawful business that the company may engage in under Chapter 621, Florida Statutes, as may be amended from time to time, including investing the funds of the Company in real estate, mortgages, stocks, bonds, or any other type of investment, or owning real or personal property necessary for the rendering of said professional legal services.

ARTICLE IV - DURATION

The period of duration for the Company shall be perpetual.

ARTICLE V - MEMBER UNITS

The Company is authorized to issue 10,000 Units of membership interest, which Units shall evidence the interest of the members of the Company, which Units shall be designated "Member Units." The interest of the members of the Company shall be evidenced by the Certificate of Company Units issued by the Company and setting forth the number of Member Units issued and outstanding in the name of such member.

Each manager shall serve until the first annual meeting of the members of the Company or until their successors are elected and qualify. 
ARTICLE VII - INITIAL REGISTERED AGENT AND REGISTERED OFFICE
