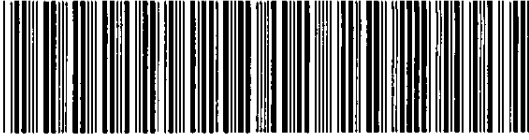

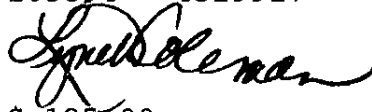

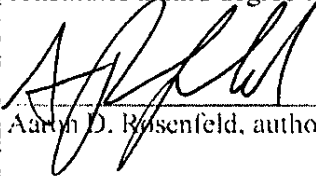
**Article IV – Management**
