**ARTICLES OF ORGANIZATION
OF
HOLLAND & KNIGHT UNITED KINGDOM LLC
(a Florida Limited Liability Company)**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

- FIRST: The name of the limited liability company is HOLLAND & KNIGHT UNITED KINGDOM LLC (the "Company").
- SECOND: The principal and mailing address office of the Company is 524 Grand Regency Blvd, Brandon, FL 33510.


